# Faced with an armada of EU and Remainer ineptitude, Boris is the luckiest general in history

But the most controversial choice by far has been the recent confirmation of **Laura Codruta Kovesi** (<https://hrwf.eu/wp-content/uploads/2019/09/From-the-Judiciary-in-Romania-to-the-EPPQ-in-Brussels-%E2%80%93-The-Tactical-Field-of-the-Romanian-Secret-Service-1-2.pdf>) as the

new EU Chief Prosecutor. Determined to have the worst possible candidate fill the role, the EU ensured that the disreputable prosecutor was fast-tracked through the process, waiving its own rules that the holder of such an important office have “high ethical standards and personal integrity” and ignoring the pleas of Romania’s elected government who had sacked her as head of the country’s National Anticorruption Directorate **for abuse of office** (<https://www.bbc.co.uk/news/world-europe-49759680>).

Kovesi’s resumé includes: presiding over the biggest spy corruption scandal since the fall of the Soviet Union by illegally colluding with **Romania’s secret intelligence service** (<https://hrwf.eu/wp-content/uploads/2019/09/From-the-Judiciary-in-Romania-to-the-EPPQ-in-Brussels-%E2%80%93-The-Tactical-Field-of-the-Romanian-Secret-Service-1-2.pdf>) to use the judicial system as a ‘tactical field of intervention’, undermining the rule of law through unlawful detentions backed by allegedly **falsified evidence**

of nearly 80 high profile defendants in her last six months in the job alone – defendants her department had confidently declared guilty. Kovesi is unrepentant about her use of **illegal wiretaps** (<https://www.rferl.org/a/interview-laura-codruta-koevesi-the-b%3%Aate-noire-of-romanian-corruption/29944326.html>), and analysts have expressed fears that she will use similar tactics across the EU once her department goes live in 2020. Her appointment is a gift to Johnson and a nightmare for every MEP and EU member state, who may well face a Tory leader with a new mandate determined to extract further significant EU concessions to their front and a Stalinist prosecutor marauding through their ranks to the rear.

*“During the last five years, the NDA has gotten on trial more than 68 dignitaries/high-ranking officials: 14 ministers and ex-ministers and 53 members of Parliament. Of these, 27 dignitaries have already been found guilty. **The rest of the cases are still in progress.** During the same term, the NDA has taken measures to insure more than 2.3 milliard dollars. (...) There have been repeated attempts to limit the efficiency of our investigations through modifying anticorruption laws in order to limit the means at the disposal of*

*anticorruption prosecutors or to not lift the immunity of politicians accused of crimes of corruption. The whole justice system has faced attacks through fake news or public statements meant to weaken confidence*
