The lawyer's (legal) profession is regulated in Romania 51/1995, as amended, which provides (art. 1.2) that the lawye profession can be caried out only by lawyers enrolled in a b the "Uniunea Nationala a Barourilor din Romania" (National Assoalations of of Romanian Bars - UNBR). The setting up or the operation f bar gatside the UNBR is forbiden by law and all documents issued entities are null by law (art. 1.3).
"Uniunea Nationala a Barourilor din Romania- Sindacatul Indipendent al Juristilor din Romania - UNBR Pompiliu Bota" is an entw which works unlegal and any person who claims to be a lawye memore of this entity, commits a crime and can be subject to penal procedures. Mr. Pompiliu Bota was already convicted by a penal court in Romania.

In addition, at the moment of submalng the application, the candidate must prove that he or she is graduated a law university and must have a diploma recognised by the Romanian Ministry of Education.
